APPROVAL OF MINUTES AND FINANCIAL STATEMENT

Director Capurro made a motion to accept the Minutes and Financial Statement for January along with payment of checks drawn on Bank of America #9039 through 9048, checks drawn on Nevada State Bank #2267 through #2271. Motion was seconded by Director Nevin, motion carried.

FEDERAL WATERMASTER'S REPORT

Brian Casci, from the Water Master's office gave the water report, a copy of which is inserted in the Minutes Book. In flow is being passed to make Floriston rates at this time. Tahoe elevation is 6226.83 with 239 cfs being released. Boca storage is 6744 AF with 25 cfs being released. Lahontan storage is 206321 AF.

FLORISTON RATES

Director Capurro stated the lowering of Floriston rates cannot be done until Lake Tahoe elevation is below 6225.8 per Court Decree.

ISSUES/DUTIES FOR CONSULTANT/ENGINEER

The Board of Directors welcomed Lori Williams of TriSage Consulting as our new Consultant/Engineer. Attorney Bergin reviewed a contract presented by TriSage and recommends signing same. At any time in the future an update needs to be made on the HEC RAS model a cost proposal will be represented at that time. A contract will be signed between the parties on a times and material's basis. Duties for engineer will include review of all encroachment permits with recommendations to Board as to approval; give a monthly report to Board as to all meetings attended and work accomplished during the previous month; attend all meetings covering the Truckee River from

the State line to the Glendale Bridge; perform the annual Truckee River Inspection with the USACE and look over the on-going projects funded by the District on Carson River

Director Schank made a motion for the Chairman to sign on behalf of the Board a contract with Tri Sage Consulting with a letter stating the work to be accomplished by said Engineer. Director Dennis seconded said motion, motion carried. Ms. Williams will attend a meeting on March 27th with the USGS regarding stream gauging.

MOVING OF LGIP FUNDS

Staff informed Directors the current interest rate as of February 8^{th} is 0.1004% on the \$774,246.98 currently held in the Local Government Investment Pool.

Robbie Johnson, First Independent Bank quoted the following rates:
