Reservoirs on the Truckee are filling. March precipitation at Tahoe was 12.32 inches which was number 4 all time and Boca had its largest precipitation in March ever.

SNOTEL numbers are: Truckee River Basin 71%; Tahoe Basin 56%; Carson River Basin 76%; Walker River Basin 74%.

Director Olsen advised that Lahontan is spilling and was put into flood ops as of yesterday.
